ICA Chiropractor of the Year Dr. Deed Harrison has Research Published in a Nature Journal: *Scientific Reports*

Falls Church, Virginia (July 29, 2021)

The International Chiropractors Association (ICA) congratulates Dr. Deed Harrison, ICA's most recent Chiropractor of the Year for publishing the findings of a placebo controlled, randomized controlled trial study in the prestigious *Nature Scientific Reports*. The paper entitled "Demonstration of central conduction time and neuroplastic changes after cervical lordosis rehabilitation in asymptomatic subjects: a randomized, placebocontrolled trial"¹ was published this week and is available through [Open Access](#).



and included Professors Aliaa A. Diab and Fatma Hegazy, and Dr. Deed E. Harrison. Their research focused on disorders of the

cervical spine, which are known to be among the greatest contributors to spine pain, disability, and work loss worldwide. As these experts noted, "there are wide variations in assessment methods and treatment approaches for patients presenting with cervical spine disorders. Problematically, most treatments for neck disorders have limited efficacy and this is particularly evident after longterm, post-therapeutic follow-up." The team noted the general agreement on the need for conservative treatment approaches for cervical spine abnormalities and determined to conduct research needed to fill the evidence gaps. The researchers observed that "Cervical spine alignment

A Conversation with ICA's New Vice-Chair, Dr. Amit "Jimmy" Nanda

Dr. Nanda, Congratulations on your historic election as the ICA's first Vice-Chairman of the ICA Board from outside the United States. What was your path to chiropractic?



Thank you. I am honored and privileged to stand on the shoulders of Chiropractic giants that served before me. We, as the ICA set an example to the world by shattering the glass ceiling in our profession. We have elected the first female Chairperson for the ICA and put its faith in me in me as the first Canadian and visible minority Vice-Chair of this esteemed organization. I got into Chiropractic by accident and have never looked back. After graduating in 2003, from Life Chiropractic College West, I opened up my first practices in Toronto, Canada and in New Delhi, India. I was focused on introducing Chiropractic to India and expanding Chiropractic to the masses there as well as here in Canada. I opened over 25 successful clinics over the next several years. I then got involved in Chiropractic advocacy.

I have served on several chiropractic related boards. Most recently, I served as Chairman of the IACD India Board and as the Chairman of the Board of Regents of Life Chiropractic College West (LCCW) based in California.

I understand that you hiked to the Everest Base Camp in Nepal in March 2020 – Just as the COVID Pandemic Hit.

I understand that you hiked to the Everest Base Camp in Nepal in March 2020 – Just as the COVID Pandemic Hit.

This was an adventure like no other. The trip had been planned for more than a year. Before leaving Ontario for Nepal, we were that everything was safe. There were no travel restrictions. On Day 3 of the hike, at a remote location in the mountains, we received word that an official pandemic had been declared and that all returned flights through India to return home had been cancelled. We had no choice but to finish the hike to Everest Base Camp and helicopter back to Kathmandu.

Arriving at the airport was like a scene out of a movie – extreme panic, hundreds of extremely anxious people just trying to get home, afraid of the unknown. We keep trying to find any flight back to Canada. As soon as we found a flight, and think we were headed home, it would be canceled a few hours later with new restrictions. We finally got one of the last flights out of Nepal and made our way safely back to Canada.

The trip itself was absolutely amazing. The beauty and serenity of the mountains is surreal. To finally reach the Everest Base Camp, look up at the Peak of Everest was spiritual. This experience was humbling for me, it showed how insignificant we are in the grand scheme of things and how we as human beings need to shed our egos and work together for humanity. It was a beautiful and fulfilling feeling. The hike pushed my physical and mental limits to do something that I was not sure was possible had it not been for my training and through chiropractic conditioning. This was a bucket list experience for sure.

Do you anticipate the Canadian-US Border to open again in the near future for chiropractors to travel between the two countries a two week mandatory quarantine upon return?

Yes, I do, as the Canadian COVID cases begin to ease, it is anticipated that the government will allow non-essential travel to begin by June or July 2021.

Less than two years after the ICA published a report on the importance of increasing diversity in the chiropractic

profession, you have been elected by the ICA Board to serve as the Board Vice-Chairman – the number two elected position of the ICA. What is your message to men and women in chiropractic or considering chiropractic who as you often refer to yourself are a ‘visible minority’ about engaging with the ICA?

My message is quite simple Chiropractic is for humanity. Chiropractic does not discriminate. We need more diversity and diverse opinions. The ICA is ‘International’ and represents all colors, religions, and cultures. I am honored to be elected as the first visible minority and I represent what the world looks like. If not for Harvey Lillard, an African American man, there would be no chiropractic today. Let that sink in. He as an African American, actually helped discover chiropractic by letting Dr. D.D. Palmer know that his hearing was restored. He should be equally celebrated.

ICA’s mission is to protect and promote chiropractic worldwide, how do you envision advancing that mission in your new role as Vice-Chair?

Prior to this role I was elected as the International Director for the ICA. For the last two years I travelled the world to be the voice for the international Chiropractic community. We had a record number of International members join over my term and I have put some projects in place to engage our international chiropractors and grow the membership globally. The ICA was always meant to be ‘international’ and our founder, Dr. B.J. Palmer had a vision chiropractic world-wide and we as an organization are fortunate that we are making that vision come true.

I foresee a rapid and robust growth in International membership as I assist Dr. Selina Sigfoose Jackson, our Chair on focusing on the advocacy needs of our International membership. has been shown to be significantly related to patient outcomes and conducted a placebo-controlled, randomized controlled trial at Cairo University utilizing the Denneroll cervical orthotic for cervical traction (used frequently by doctors of chiropractic with post graduate training in Chiropractic Applied Sciences and Chiropractic Biophysics.)

The research team identified a reduced cervical lordosis and anterior head translation is associated with differences in neural activity at several regions (cortical and subcortical) of the somatosensory system. Restoration of the cervical sagittal alignment, in terms of increased cervical lordosis and reduced

anterior head translation, has a direct influence on the central conduction time. Clinical interventions directed at improving central processing through restoring the normal sagittal alignment could be added to clinical interventions targeting specific spinal disorders. Importantly, this study adds to the literature supporting subluxation detection and correction using X-ray mensuration analysis.

The prestigious *Scientific Reports* is a *Nature* journal and is the 6th most cited research journal worldwide. Dr. Hegazy is affiliated with the University of Sharjah, Sharjah, in the United Arab Emirates; and Dr. Diab is affiliated with Cairo University, in Giza, Egypt. Dr. Moustafa has affiliations with both the University of Sharjah and Cairo University.

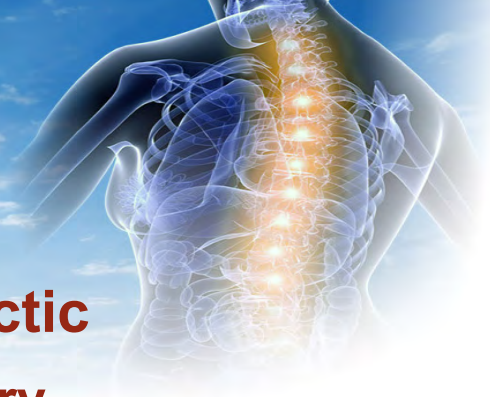

ICA — Protecting the Core Values of Chiropractic

The ICA is dedicated to its Mission Statement: “To protect and promote chiropractic throughout the world as a distinct health care profession predicated on its unique philosophy, science, and art of subluxation detection and correction.”

The one thing that makes the chiropractic profession unique from all other fields of healthcare is the subluxation. Chiropractors may utilize other procedures and services in their offices, but the correction of the subluxated spine and the resultant impact upon the function of the nervous system and overall health stands solitarily at the center of our profession. Critics of chiropractic within our own profession espouse that the correction of the subluxation is outdated and unscientific. This is contrary to the vast majority of practicing chiropractors. In the largest survey of North American Chiropractors, it was shown that over 88% of chiropractors wish to retain the term vertebral subluxation complex.¹ And 89.8% believe the adjustment should not be limited to musculoskeletal conditions.¹

One of the most commonly used tools to detect and measure subluxation over the 125-year history of the profession has been the use of radiography. However, the use of Xray has come under threat recently. For example, a “rapid review” of the literature was published in 2020 that concluded, “we recommend that chiropractors do not use radiographs for the routine and repeat evaluation of the structure and function

of the spine.”² They also stated, “Given the inherent risks of radiation, we recommend that chiropractors do not use radiographs for the routine and repeat evaluation of the structure and function of the spine.”²

The Research and Development Committee of the ICA has written a critique of this paper. The authors included only 9 papers in their rapid review, the most recent of which was from 2005. ICA researchers found that the rapid review missed many studies that fit their overly restrictive inclusion criteria. In addition, over 200 other articles should have been included in their rapid review, if it were not for the faulty design of the paper. Undoubtedly, this would affect their conclusion. The Commentary paper written by ICA researchers is in review at a high-quality peer-reviewed journal.

While other organizations in Chiropractic are motivated by advancing the acceptance of spinal manipulative therapy for low back pain into the medical model, ICA has always been the one organization that protects and promotes the science, art and philosophy of subluxation detection and correction. ICA works to keep the uniqueness of Chiropractic at the forefront of the advancement of our profession. As our profession continues to grow, it is the ICA that will ensure that the impact we have on human health gains recognition and acceptance for the betterment of humanity.

A slip on the snowy sidewalk, in winter, is a SMALL thing. It happens to millions. A fall from a ladder, in the summer, is a SMALL thing. That also happens to millions. The slip or fall produces a subluxation. The subluxation is a SMALL thing. The subluxation produces pressure on a nerve. That pressure is a

To enter the D.C. program, students must have at least 90 semester hours of college-level courses, including courses in the sciences.

"This is the second conference in a row that the CCR has been represented with an award. It means that our hard work and commitment is beginning to pay off."

The Best of Conference award was presented to the team of Drs. [Brent Russell](#), [Ron Hosek](#), and [Ed Owens](#), as well as LIFE Doctor of Chiropractic student Mackenzie Keller and Dr. Shari Wynd from Texas Chiropractic College, for their presentation on the topic of Angular kinematics of supine cervical spine adjustment: phase 2. Five other CCR teams also presented at the conference.

In addition to its groundbreaking research, CCR has impacted how [Life University Doctor of Chiropractic](#) students learn the specialized skills and techniques they need to care for patients. Years of work went into the development of [PAT](#) (Palpitation and Adjustment Trainer), the most advanced palpation and adjusting technology in the Chiropractic profession.

PAT is an anatomically accurate, technology-based mannequin with the look, feel, size and weight of an average person. LIFE D.C. students have been using PAT and its accompanying force plate technology over the past year to refine the most important patient care tool that chiropractors have: the adjustment.

Life University also continues to expand Chiropractic's reach around the world through its Global Initiatives. Several LIFE Chiropractic Clinics are slated to open in Hong Kong this summer, thanks to the work of LIFE Vice President of Global Initiatives Dr. John Downes and his team. The clinics will build on LIFE's outreach and education efforts in other parts of the world, including those underway in Costa Rica, Germany and Switzerland, bringing Chiropractic to a wider audience and inspiring future doctors to pursue a career in the profession.

One of his passions is building the [President's Circle](#), where every dollar that the college receives goes into enhancing the student experience on campus or helping financially for service trips and beyond, and making sure that everyone shares in our successes, energy and growth.

When he started out as president, after a series of focus groups and processes of community engagement, Dr. Oberstein worked diligently with the colleges stakeholders to introduce a new [Seven Year Strategic Plan](#) that has seven initiatives: a Clinically Inspired Curriculum that starts at day one; a

diversity and inclusion drive that enables structural change on and off campus; a culture of service for all our community; greater engagement with our alumni and stakeholders; embedding innovation and decision making from data in all we do; broadening our program offering beyond the DC program; and ensuring long-term financial security for the college. Together, these initiatives are setting the college up for success in the present and future years.

The first student cohort that entered the Clinically Inspired Learning (CIL) program is now soon to graduate out into practice. They have had hands-on experience since the first quarter and entered into their clinical experience a year earlier than the cohorts before them. Our graduates will only have better adjusting skills if they can continuously practice at college and starting earlier in their degree program gives them the added advantage with more time and repetition. Added to that over 75% of senior interns are now out on preceptorships, working in DC offices learning about practice in the real world outside the "Life West Bubble" as the students like to call it. The aim now with the next iteration of the CIL program is to have them complete their clinical competencies even earlier so they can spend their full last year in preceptorships. Given the large numbers of interns at the college, the college is always [looking for more preceptor doctors](#) to partner with us. Covid has slowed the Life West service trips, but as the borders start to open up, [college service in India and Tonga](#) and our clinic in New Delhi will soon be back up and running. We will also be starting our Panama service trip this year as well. When Life West students return from their service trips and/or working in our Delhi India clinic, they are changed people. Adjusting clinical conditions they would never see at home, understanding the enormous need in the world around us, and learning the true meaning of service are just a few of the reasons Life West will continue to create these opportunities. They also see the beautiful and deeply human diversity that surrounds us.

Here at home, we have our own diversity that needs to be understood, respected, and honored. For that reason, Dr. Oberstein has worked to raise the profile of diversity and

inclusion efforts within the profession. The profession is a long way from representing the diversity of the U.S. population. It can and must do better. Life West has hosted a number of D&I summits and workshops for the profession, and the college is happy to share our plans, processes, and policies with all that might find them useful.

Staying true to our Lasting Purpose for the next 40 years is the challenge we have in front of us. Life West is more than up for the challenge. The college is embedding its values into the curriculum, clinic, and student life through the Lasting Purpose Experience. This will brand and identify graduates as Life West. Each value - Give, Do, Love and Serve - is being themed into courses, academic support and student life

through training, workshops, and seminars, with a reflection project at the conclusion of each phase.

Next year will mark 125 years since D.D. Palmer opened what was then known as the Palmer School of Chiropractic, just two years after performing the first chiropractic adjustment. They would see that today Palmer graduates account for more than one-third of all practicing chiropractors, and currently, one in every five chiropractic students around the world have chosen to study in the very space where they once taught.

While chiropractors in the early days were persecuted for their profession, chiropractors are now welcomed and embraced by major integrated health-care systems, elite athletic teams, and corporate settings.

Through partnerships with Veterans Affairs hospitals and Department of Defense sites, our students have opportunities to complete clinicals in approximately 50 locations across the country.

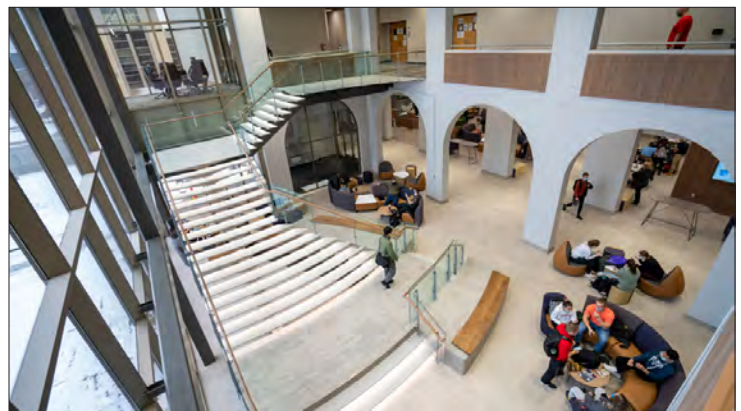
Nearly every team within the NFL, MLB, and NHL, as well as many U.S. Olympic teams, have at least one chiropractor on staff as professional athletes view chiropractic as essential to their peak performance.

The Palmer Center for Chiropractic Research is the largest and most highly funded chiropractic research effort in the nation. Over the past 10 years alone, the Center has secured more than \$35 million in private and federal grant funding to advance chiropractic research – a direct indicator that a growing number of health-care professionals endorse the value of chiropractic. These research efforts have influenced academic curriculum, insurance, legislative policy related to chiropractic care, and greater public recognition of the benefits of chiropractic.

In 2020, as many industries, including higher education, were

shaken by a global pandemic, Palmer College experienced growth in enrollment as more people recognize the impact they can have as doctors of chiropractic. This exciting growth in enrollment is matched by changes to our campuses.

Palmer's main campus, the Fountainhead of Chiropractic, recently completed construction on new spaces including the David D. Palmer Learning Commons, the Bruce & Bethel Hagen Student Union, the Trevor V. Ireland Student Clinic, NCMIC Center for Business Development and the R. Richard Bittner Athletic & Recreation Center. In total, \$35 million in renovations have been completed since 2017, offering students a beautiful and modern learning environment among the history of the profession.



The next phase of construction has just begun. We look forward to completing new student housing, the Charles J. Keller Terrace and an Experiential Learning Center that will allow students to move seamlessly between Palmer's anatomy classrooms, wet and dry labs, and technique classrooms, transitioning from practice to learning, concept to skill, and back again in the same environment. At Palmer Florida, a massive fourth academic building will be completed this fall to meet rising enrollment demands.

I believe D.D., B.J., Mabel and Dr. Dave would be proud – Palmer Proud – to see that their passion and conviction has endured in a profession that continues to inspire unlimited health and human potential around the world.

I invite everyone to join us and celebrate the 125th anniversary at the fountainhead of chiropractic in Davenport, Iowa, September 14 – 17, 2022.
